ORGANIZATION

MHHC Foundation, Inc. ("MHHC") received its incorporation documents under the Not-For-Profit Corporation Law of New York State, in May 1985. MHHC is exempt from income tax under Section 501 (c) (3) of the Internal Revenue Code and is organized under Section 402 of the Not-For-Profit Corporation law of New York.

MHHC was formed as a corporate parent of Morris Heights Health Center, Inc. ("The Center") to perform certain functions to achieve the basic objective of delivering health care to the community surrounding the Center in a more efficient manner. MHHC expects to contribute funds to the Center to assist it in its operations. For the Years ended May 31, 2012 and 2011, MHHC's support and revenues were provided by a grant, special events, rental income and interest income.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following significant accounting policies are set forth to facilitate the understanding of data presented in the financial statements:

Financial statements presentation follows the recommendations of the Financial Accounting Standards Board Accounting Standards Codification (ASC) No. 958, "Not-for-Profit Organizations." Under ASC No. 958, non-profit organizations are required to report information regarding their financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets.

The Foundation reports gifts of cash and other assets as restricted support if they are received with donor stipulations that limit the use of the donated assets. When a donor restriction expires, that is, when a stipulated time restriction ends or purpose restriction is accomplished, temporarily restricted net assets are reclassified to unrestricted net assets and reported in the statement of activities as net asset released from restrictions.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Cont'd)

Revenues and expenditures are recorded on an accrual basis, thereby recognizing revenues when earned and expenses when incurred.

For purposes of the statement of cash flows, MHHC Foundation, Inc. considers all highly liquid debt instruments purchased with maturity of three months or less to be cash equivalents.

Investments consist of Municipal Bonds and Certificates of Deposit with original maturities in excess of three months. Investments are stated at fair value. Investments in equity securities with readily determinable fair values and all investments in debt security are reported at fair value, with gains and losses included in the statement of operations.

Property and equipment are stated at cost. Depreciation and amortization is computed on the straight-line method over the estimated useful lives of the assets acquired, which range from 5 to 40 years. MHHC Foundation, Inc. follows the practice of capitalizing all expenditures for property, equipment and improvements in excess of \$300.

Maintenance and repairs are charged to operations when incurred. Betterments and renewals are capitalized. When property and equipment are sold or otherwise disposed of, the asset account and related accumulated depreciation account are reduced, and any gain or loss is included in operations.

Contributions received on unconditional promises to give are recognized as revenue in the period received at their fair values. Conditional promises to give are recognized when they become unconditional, that is, when conditions are substantially met as per ASC 958. Donated services, materials and equipment are recorded at their fair market value at the time of donation.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Cont'd)

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

The financial statements include certain prior-year summarized comparative information in total but not by net class. Such information does not include sufficient detail to constitute a presentation in conformity with accounting principles generally accepted in the United States of America. Accordingly, such information should be read in conjunction with MHHC Foundation Inc.'s financial statements for the year ended May 31, 2011, from which the summarized information was derived.

CONCENTRATION OF CREDIT RISK

MHHC maintains several bank accounts at two national banks. The Federal Deposit Insurance Corporation (FDIC) fully insures all noninterest-bearing transaction accounts from December 31, 2010 through December 31, 2012, regardless of the account balance and the ownership capacity of the funds. The accounts are maintained at well-regarded, stable financial institutions with significant assets and high credit ratings. As such, MHHC's exposure to concentration of credit risk in connection with cash is significantly reduced.
