Summary of Qualification under 509(a)(1) and 170(b)(1)(A)(vi)
10% Facts & Circumstances Test
Measuring Period: June 1, 2007, through May 31, 2012

1. 10%-of-Support Limitation. For the tax years June 1, 2007, through May 31, 2012, Telluride Association's public support was 32.4%.

2. Attraction of Public Support. The Association has established the following programs to actively attract public support:

- Solicitation of Alumni. The Association has more than 5,000 alumni of its programs, and it regularly requests contributions from these individuals. Alumni are solicited through multiple channels including U.S. mail, electronic mail, and the Association's website. The Association also encourages all of its member-directors (each of whom is an alumnus of the Association's programs) to contribute both time and money to the organization.
- Solicitation of Alumni Parents. The Association also seeks contributions from parents of its current program participants and program alumni through mail, electronic mail, and the Internet.
- Bea Macleod Memorial Fund Campaign. This fundraising effort began in 2007. For more information, please *see* the Association's website at <http://tellurideassociation.org/support/beamacleod.html>.
- Grant Proposals to Major Funders. The Irvin Stern Foundation has awarded the Association two \$10,000 grants to support the Telluride Association Sophomore Seminar ("TASS"). The Stern Foundation's funding specifically supported the 2010 and 2011 TASS programs. Further, the Association submitted a successful grant application to the Sylvia Bingham Memorial Fund. The Fund's \$1,000 grant supported the Telluride Association Summer Program.

In addition to serving as a resource for the Association's members and the general public, the Association's website encourages members of the public and alumni to contribute to the Association through a simple online portal. Contributions received through this portal are administered by Network for Good, a Section 501(c)(3) public charity.

The Association is currently researching additional funding sources to broaden its sources of support. In addition to seeking donations and grants, the Association will continue to host fundraising events, conduct on-line fundraising through its website, and identify and approach potential major donors.

3. Percentage of Financial Support. Treasury Regulations section 1.170-9T(f)(3)(iii)(A) provides that "[t]he higher the percentage of support above the 10 percent

requirement of subdivision (i) of this subparagraph from public or governmental sources the lesser will be the burden of establishing the publicly supported nature of the organization through other factors described in this subparagraph” The Association’s public support percentage of 32.4% during the measurement period is well in excess of the 10% floor. The Association is working actively to broaden its sources of support.

4. Actual Sources of Support. During the measurement period, the Association received support from Cornell University, the University of Texas, the University of Michigan, Indiana University, and Washington University, all of which are public charities described in Code section 170(b)(1)(A)(ii) (and also described in Code section 170(b)(1)(A)(vi). The Association also received hundreds of small contributions from unrelated individual donors, as well as the foundation grants described in above. In addition, the Association has historically benefited from donations of time and services provided by the directors who serve as its governing body, none of whom receive compensation.

The Association does not receive significant support from any particular person or family. Although the Association’s activities are primarily focused on the communities in which it operates educational programs, the Association does not limit its activities to any special field that inherently restricts its appeal to a limited number of persons. In the future, the Association expects to derive increased support from donations from the general public, private foundations, corporate sponsors, and fundraising events.

5. Representative Governing Body. The Association’s current governing body consists of 93 directors, all of whom were first elected to membership in the Association based upon their demonstrated leadership and commitment to the Association’s educational goals. Directors must be elected by 75% of the sitting membership, and each must submit an essay and participate in an interview process. All members, and therefore all directors, are prior participants in an Association-operated program.

The Association’s governing body is composed of individuals from all backgrounds, ages, geographic areas, professions, and expertise. The current members of the Association’s governing body live in more than twenty states, the District of Columbia, and several countries, and have professions ranging from student to ship captain, professor to paralegal. More than 25% of the governing body is non-white. It would be difficult to find a governing body that more fully represents the broad interests of the public.

6. Availability of Public Facilities or Services; Public Participation in Programs and Policies. The Association conducts programs that are open to the general public, and all of its largest programs are conducted with the cooperation of one or more of its major university donors. The Association’s major programs are described on its website, www.tellurideassociation.org.

7. Additional Factors Pertinent to “Membership Organizations.” The Association does not charge annual dues. Application for membership in the Association is open to all persons who are participating or have in the past participated in any of the Association’s educational programs. The Association’s programs are intended to appeal to persons having

broad common interests in lifelong education and democratic self-government. Although the Association is not an alumni association in the typical sense, because all members and directors of the Association must at some point have participated in one of the Association's educational programs, the Association's membership is a kind of alumni group.

CONCLUSION

The Association meets each of the major factors identified in the Internal Revenue Code and Treasury Regulations as part of the 10% facts and circumstances test. It has been actively engaged in fundraising from a diverse range of potential supporters and has historically received contributions from a range of both institutional and individual donors; the Association expects to continue to receive such diverse support. The Association's governing body is fundamentally representative of the general public, and its ongoing diversity is ensured by the membership's democratic selection procedures. The Association's programs are aimed at providing unique educational opportunities to a wide range of persons, and several programs specifically provide these opportunities to economically disadvantaged young people. Finally, the Association's membership is open to all applicants who have participated in its programs and are committed to its educational and democratic principles, regardless of their demographic characteristics. The Association has long operated, and will continue to operate, in a manner consistent with publicly supported public charity status under Sections 509(a)(1) and 170(b)(1)(A)(vi).
