During those trips, volunteers worked with the local community to build a high school and completed the first story of the high school. The volunteers worked with local people and contractors to develop the infrastructure, foundation, and the development of classrooms and school building.

During the year, Surf for Life organized and conducted trips comprised of volunteers to Pureto Viejo, Costa Rica. During those trips, volunteers were able to work with the local community of Pureto Viejo to improve the grade school and community center. The volunteers worked with local craftsmen and completed projects including: remodeling the classrooms in the school, refinishing and improving the playground, building out additional community meeting rooms in the community center and refinishing the common area of the community center.
