Provided significant grants and other key support to Chicago's pro bono and legal aid organizations The CBF awarded more than \$1.8 million in grants to Chicago-area pro bono and legal aid organizations and related initiatives These grants enabled tens of thousands of low-income and disadvantaged Chicagoans to get critical legal advice and assistance, strengthened Chicago's pro bono and legal aid system, and made other longer-term systemic improvements in access to justice

Made the court system more user - friendly and accessible for those in need, particularly those without lawyers The CBF continued to play a lead role in the Circuit Court of Cook County's Mortgage Foreclosure Mediation Program, which provided thousands of people facing foreclosure much greater access to free housing counseling, and legal assistance, and in appropriate matters, access to free mediation to help homeowners reach the best resolution for their particular cases In addition, the CBF continued its leadership and support for over ten advice desks in the state and federal courts and in the City's Department of Administrative Hearings as well as several innovative court-based pro bono projects, and continued to play a leadership role in coordinating the work of these various initiatives

Invested in the attorneys dedicating their careers to legal aid The CBF made it possible for 35 dedicated attorneys and law students to pursue careers in legal aid through the CBF's Sun-Times Fellowship, the Anderson Fellowship, the Moses and the Marovitz Public Interest Law Scholarships, and the CBF's sponsorship of Equal Justice Works public interest law fellowships and PILI law student internships In addition, the CBF continued to administer the CBF Legal Aid Academy, an innovative pro bono program through which law firms, legal aid organizations, academic institutions, consultants and other professionals are collaborating to help meet the core training and professional development needs of our community's legal aid attorneys and staff The CBF's grants in this area totaled over \$300,000
