Instructional - Riverside Military Academy (RMA) is an all-boys college preparatory boarding school serving students in grades 7-12. There are approximately 430 cadets from about 25 states and 19 countries. The average class size is 14 students. This individualized attention and highly structured environment prepares the cadets for college and success in many occupational fields. Of the 85 seniors, 83 are attending/were accepted to over 100 different colleges/universities. Two cadets entered military service even though they were accepted to a college. The graduating class received \$2.0 million in collegiate scholarships to colleges and universities spanning the United States, Mexico and Canada. There are a total of 42 faculty members, and over 70% of these have advanced degrees.

Athletics - RMA competes in four Junior Varsity and three Prep level sports. The Academy also competes within Region 8-AA of the Georgia High School Association (GHSAA) in 12 varsity level sports. The golf team was the 2012 runner-up in 8-A region and advanced to the state playoffs. The soccer team advanced to the 2012 state playoffs with wrestling, track, tennis and swimming sending individuals to the state playoffs. In total, 206 cadets received letters in varsity sports. After a five-year hiatus, the crew team was reestablished during the 2010-11 year and is still an active sport.

Student Services - The vast majority of the cadets live on the 206-acre campus. The campus facilities include dormitories, classrooms, a visual and performing arts center, library, gymnasium, an extensive weight-training facility, an indoor rifle range, cafeteria and grill, book store, swimming pool, tennis courts, and lighted athletic fields. The school offers over 30 different clubs and activities for cadets to participate. The school cafeteria provides three meals a day Monday - Friday and two meals on Saturday and Sunday. They serve all of the cadets and approximately 50 members of the faculty and staff.
