MAPS STAFF OR VOLUNTEERS PARTICIPATED IN THE FOLLOWING EVENTS THIS YEAR: CANNABIS CUP, LOS ANGELES; SAN FRANCISCO, DENVER, AND SEATTLE; DIVERSITY FESTIVAL, BRITISH COLUMBIA, CANADA; HARMONY FESTIVAL, SANTA ROSA, CALIFORNIA; STAN GROF LECTURE, ESALEN INSTITUTE, BIG SUR, CALIFORNIA; HORIZONS CONFERENCE, NEW YORK, NEW YORK; THE INSTITUTE OF NOETIC SCIENCES, PETALUMA, CALIFORNIA; BREAKING CONVENTION, UNITED KINGDOM; VISIONARY ART FAIR, ATLANTA, GEORGIA; MANIFESTATION CELEBRATION, DALLAS, TEXAS; PLANT, SPIRIT, AND MEDICINE CONFERENCE, BRITISH COLUMBIA, CANADA; A BALANCED APPROACH TO CLINICAL RESEARCH; WOMEN'S VISIONARY CONGRESS, PETALUMA, CALIFORNIA.
