Established in 1923, The Blue Bird Circle is a women's volunteer service organization celebrating 88 years of service to the Houston community For many years, the focus of the Circle has been to support both the treatment of children with neurological disorders, and the research into the causes and treatment of those diseases Over 500 Circle members devote at least 50,000 hours every year working in The Blue Bird Circle Clinic for Pediatric Neurology at Texas Children's Hospital or in The Blue Bird Circle Resale Shop and other fundraising activities to support the Circle's charitable causes The Shop is substantially run by the volunteer members of the Circle and provides an important source of funding to enable the Circle to support its projects The Blue Bird Circle Clinic for Pediatric Neurology at Texas Children's Hospital is one of the largest neurology service centers in the United States, specializing in the diagnosis, treatment and follow-up care of neurological disorders in children With over 20,000 patient encounters each year, the large team of specialists cares for patients with more than 450 neurological disorders including epilepsy, multiple sclerosis, developmental delay, sleep disorders, stroke, cortical malformations, and brain tumors The Clinic also diagnoses and treats such rare disorders as Rett syndrome, Angelman syndrome, Fragile X syndrome, Batten's Disease, and Prader-Willi syndrome Satellite neurology clinics are located in Clear Lake, Sugar Land, The Woodlands, and TCH West Campus

The Blue Bird Circle Developmental Neurogenetics Laboratory at Baylor College of Medicine continues to perform ground-breaking research into the causes and treatments of neurological disorders in both children and adults including seizures, stroke, brain trauma and other neurodegenerative disorders

The Blue Bird Circle Rett Center at Baylor College of Medicine is one of the few centers in the world that specializes in the diagnosis and care of patients with Rett Syndrome, a neuro-developmental disorder that develops almost exclusively in females The syndrome causes chronic neurological problems that include severe communication and motor disabilities There is no known cure for the disorder, but the Center offers a multi-disciplinary approach focused on care, education, and research that will improve the quality of life for patients and their families
