In 2000, MPC, in partnership with the Houston Parks Board and Houston Parks and Recreation Department, began a process including public comment to develop a Conservation Master Plan for Memorial Park. The Master Plan was approved by the Houston City Council in 2004. As a result, MPC announced a \$10 million Capital Campaign to raise funds for major projects and improvements in Memorial Park. MPC has raised significant funds and is in the process of executing the projects included under the Capital Campaign. Memorial Park accommodates approximately 10,000 runners/walkers each day. In FY 2012, MPC completed construction of Phase 1 of the Outer Loop Trail, an all-weather multi-use trail that connects the Living Bridge (constructed in FY 2010) to the north entrance of the Park. MPC expects to begin Phase 2 of the trail construction in FY 2013. In FY2012, MPC completed the design for a Running/Trails Center to be constructed on the south side of the Park near the Living Bridge. Construction for the Running/Trails Center is expected to begin in FY 2013.

Memorial Park is a 1500 urban acre park, which is approximately 50% forested. Due to the severe drought in 2011 and 2012, and anticipated issues with the forest, MPC developed a comprehensive forestry management plan. Memorial Park was severely impacted by the drought during the spring and summer of 2011. Thousands of trees were lost. In FY 2012, MPC engaged experts to plan the reforestation of the Park. The project, begun in FY 2012, will continue for years to come with the goal of removing dead trees, clearing underbrush and invasive plants, preparing the soil, and replanting the forest with a variety of tree species. Additionally, MPC hired a Conservation Director for forestry restoration and management.

Memorial Park accommodates approximately 10,000 runners/walkers each day. Trails are a vital part of the use and enjoyment of Memorial Park. The trail system includes a variety of trails, ranging from the popular Seymour-Lieberman Trail to narrow paths winding through the woods near Buffalo Bayou. During the year, MPC continued its efforts to improve and maintain existing trails.
