THE DENTAL CENTER IS OPEN THREE DAYS PER WEEK TO PROVIDE CRITICAL, EMERGENCY DENTAL CARE TO CHILDREN REFERRED BY SCHOOL NURSES FROM POMONA, SAN DIMAS, LA VERNE, MT. BALDY, AND CLAREMONT SCHOOL DISTRICTS. THE PATIENTS SERVICED ARE OFTEN CHILDREN OF THE "WORKING POOR" WHO ARE INELIGIBLE FOR GOVERNMENT PROGRAMS. AN AVERAGE OF 500 CHILDREN RECEIVE SERVICES ANNUALLY, WITH OVER 1500 TREATMENTS GIVEN THROUGHOUT MULTIPLE APPOINTMENTS. SERVICES ALSO INCLUDE PREVENTATIVE DENTISTRY AND EDUCATION, SCHOOL SCREENINGS, FLUORIDE TREATMENTS, ROOT CANALS, SPACE MAINTAINERS, AND CROWNS. THE DENTAL CENTER IS APPOINTED WITH THREE OPERATORIES AND IS STAFFED WITH A PEDIATRIC, BILINGUAL DENTIST, DENTAL ASSISTANT, AND AN OFFICE MANAGER/RECEPTIONIST WHO RECEIVE FINANCIAL COMPENSATION FOR THEIR SERVICES.

OPERATION SCHOOL BELL (OSB) PROVIDES NEW CLOTHING AND SHOES TO OVER 1,200 SCHOOL-AGED CHILDREN ANNUALLY. FOR MANY OF OUR RECIPIENTS, THIS IS THE FIRST OPPORTUNITY THEY HAVE HAD TO SELECT AND HAVE NEW CLOTHING OF THEIR OWN. WE PROVIDE MULTIPLE SCHOOL APPROPRIATE OUTFITS WHICH ALLOW MANY OF OUR RECIPIENTS TO ATTEND SCHOOL ON A REGULAR BASIS. WE FURNISH UNDERWEAR THROUGH OUTERWEAR, AS WELL AS A BACKPACK AND SCHOOL SUPPLIES FOR EACH CHILD. EVERY EFFORT IS MADE TO ENSURE QUALITY CLOTHING IS PROVIDED WHICH IS COMPARABLE TO PEER APPAREL. SCHOOL NURSES IDENTIFY CHILDREN IN NEED OF CLOTHING AND REFER THEM THROUGH A CONFIDENTIAL PROCESS. OUR COMMUNITY CLOTHES CLOSET PROGRAM PROVIDES GENTLY USED CLOTHING TO OSB FAMILY MEMBERS OR OTHERS IN THE COMMUNITY FACING LOSS THROUGH FIRE, DISASTER, OR OTHER EMERGENCY.

THE LES FLEURS AUXILIARY OF ASSISTANCE LEAGUE OF POMONA VALLEY PROVIDES FAMILY HYGIENE KITS CONTAINING LAUNDRY DETERGENT AND TOILETRY ITEMS FOR EACH OPERATION SCHOOL BELL FAMILY. POLICE AND FIRE PERSONNEL DISTRIBUTE "CUBS FOR KIDS", DECORATED TEDDY BEARS FURNISHED BY LES FLEURS, TO CHILDREN AND OTHERS WHO ARE THE VICTIMS OF TRAUMA OR LOSS. LES FLEURS ALSO PREPARE AND DISTRIBUTE ASSAULT SURVIVOR KITS IN CONJUNCTION WITH PROJECT SISTER TO ASSIST VICTIMS OF ASSAULT.
