During the year, MDNA has had 16 admissions and 20 discharges including 3 deaths. MDNA nurses have called the ambulance 6 times on behalf of patients. A total of 173 patient visits were made to the office. This number does not include all the visits from persons borrowing Loan Closet Equipment. The Loan Closet provided durable medical equipment to 145 Mount Desert Island residents, for a total of approximately 205 pieces of loaned equipment. Most of this equipment is returned within a few weeks or months and then needs to be cleaned and restocked into the basement.

In addition to the 1,368 regular patient care visits, the nursing staff spends many hours conferencing with health care professionals, individuals, and families by phone. During the year our RNs have made
