Community-based Services: Family Planning Association of Maine (FPA) provides funding, technical support and quality assurance to 46 clinics statewide in addition to operating clinics in Augusta, Belfast, Damariscotta, Rockland, Skowhegan, and Waterville serving the family planning needs of approximately 27,000 low-income Maine women, men and teens annually. FPA's services are confidential, offered on a sliding fee scale, state-of-the-art, and include:

* comprehensive medically accurate reproductive health care information to help clients make informed decisions about their reproductive health and lives

* gynecological exams

Education and Research Projects: In 2012, the FPA designed new resources to reach Maine teens through new media with medically-accurate, age-appropriate information and resources. Designed with input from Maine teens, www.maineteenhealth.org provides sexual health information, a guide to Maine's family planning clinics, and an interactive place to get answers to their sexual health questions. With the FPA's new text messaging service, AskMTH, teens can use their cell phones to text anonymous questions and get answers from a trained family planning professional.

During FY 2012, our Teen Pregnancy Prevention Program continued its work through the federally funded Personal Responsibility Education

Agency and Mission-related Projects: Since 1971, the FPA's Public Affairs staff has worked to protect the reproductive rights of all Maine citizens. The Family Planning Association is founded on the premise that Maine women and teens must have access to comprehensive reproductive health care and information in order to control their reproductive lives. The FPA Public Affairs efforts are designed to promote and protect programs and services statewide to ensure affordable access to family planning.

Policy work in Maine this year has been dominated by health care reform and attacks on the family planning budget. Maine's Legislature had several process decisions to make in response to the Affordable Care

Program (PREP), partnering with Jobs for Maine's Graduates (JMG) to deliver evidence based programming. This year, nearly 300 students participated in the All4You! curriculum in seven high schools located in Maine communities with high teen pregnancy rates. Evaluations showed increased knowledge and improved attitudes around HIV/STDs, pregnancy prevention, and behaviors that put teens at risk and preventive measures like abstinence, birth control and condom use.

In addition, in 2012 our Prevention Coordinators worked with sexuality educators to deliver a variety of evidence-based, comprehensive sexuality education curriculums focused on preventing HIV/STDs and pregnancy to 1,970 middle and high school students in twelve schools. In order to sustain sexuality education efforts, we continue to provide training and professional development through web-based sessions, in-person trainings and statewide conferences. This year, a total of 279 educators from schools, youth-serving organizations and government agencies attended these training opportunities.

Similar to our Community-based services, funding for the FPA's education and research projects is provided by State and Federal agencies (that also monitor program operations and outcomes), foundation grants and other restricted revenues.

decisions.

In response to continuing budget shortfalls, Governor LePage submitted a state budget that substantially cut state funding for family planning services. The FPA presented testimony during three days of joint legislative committee hearings. FPA's Public Affairs staff spent many weeks of the session educating legislators about the importance of family planning. Despite our best efforts, the final state budget included nearly all of the dramatic cuts proposed by the Governor including a \$401,430 cut to family planning services representing 25% of state funding for these services. By making strategic changes in our administrative structure and decreasing our Teen Pregnancy Prevention Program staffing, the FPA was able to minimize the impact of these cuts on direct clinical services.

We continue to rely on a strong network of pro-choice, pro-family planning grassroots activists who communicate very powerfully with their elected leaders. Although this legislative session presented challenges to Maine's reproductive health care system, it has strengthened our resolve and the resolve of our supporters to continue the fight to protect access to the full range of reproductive health care for all women, men and teens in Maine.

Private contributions and agency-endowed resources fund these projects. No public funds are used.
