The corporation provides abstinence education to public and private school curriculums, as well as to church youth groups.

Sixteen (16) presentations were given to approximately 600 students and parents in schools and youth groups. Fifty-five (55) program booklets were distributed. Many students resolved to remain sexually pure until marriage. Student feedback also mentioned that new and valuable spiritual truths and practical information were revealed.

4b (Code:) (Expenses \$ 2,582 including grants of \$ 0) (Revenue \$ 0)

The corporation continues the project to reproduce the corporation's education program into multiple media. The "Spider Lake" Bible study was developed and published, and has been taught to three groups. The traditional school-age program has been adapted as an online course within the curriculum of an online high school. In light of recent technological changes, publishers are now recommending that the traditional school curriculum be mass-marketed as a book/workbook that can be revised and republished through electronic media and distribution channels. The original grant received in 2007 continues to finance the project.
