PART I, LINE 10: \$23,809 in grants given to Jane Addams K-8 School (11051 34th Ave NE, Seattle, WA 98125) including \$5,000 for field trips, \$6,000 for leveled library books, \$4,000 for overnight science field experience, \$8,000 for tutoring, and \$809 for art and physical education supplies.

PART I, LINE 16: These expenses include business licenses, insurance, supplies, bank fees, committee expenses, conferences & workshops, membership dues, open house tours, outdoor learning center, family events, field day, opening events, teacher appreciation, and other miscellaneous expenses.

PART II, LINE 26: Liabilities include \$1,500 accounts payable for overnight science trip scholarships and \$1,330 for auditorium improvement.

PART III: Our organization's exempt purpose is to improve the education, health and safety of all children in our school and surrounding community.

PART III, LINE 28: These program expenses are for educational enrichment purposes. They include \$7,728 for teacher reimbursements for classroom expenses, and grants to the school as follows: \$8,000 to help pay for tutoring of approximately 200 students throughout the school year, \$6,000 for leveled library books, \$5,000 for field trips, and \$4,000 for the Nature Bridge overnight science field experience. They also include \$4,173 toward creation of an outdoor learning center and \$2,959 for a multi-cultural cookbook, drama production, art display boards and 8th grade graduation expenses.
