Established in 1920 as Community Council of Nashua, Greater Nashua Mental Health Center at Community Council (GNMHC) provides comprehensive mental health services to residents in ten towns/cities in southern Hillsborough County - Amherst, Brookline, Hollis, Hudson, Litchfield, Mason, Merrimack, Milford, Mont Vernon and Nashua Last year the agency served 5,500 consumers, a third of whom were diagnosed with a severe mental illness The agency provides a full range of psychiatric and substance abuse treatment for adults, older adults and children suffering from a wide range of conditions Individuals who meet eligibility criteria have access to state-of-the-art treatment protocols Dedicated to ensuring nondiscriminatory access to care, GNMHC serves all those in need, regardless of their ability to pay or insurance status A significant number of those served have no source of funding when they first apply for services As an organization, GNMHC is committed to the incorporation of evidence-based practices for the treatment of individuals with mental illness, adopting these practices as they evolve The staff of nearly 200 provides services that include psychiatric evaluation and treatment, individual and group psychotherapy, family education, case management, substance abuse treatment, 24-hour emergency services, supported housing, vocational services, counseling for children in Nashua's elementary schools, supervised visitation services, juvenile diversion, Assertive Community Treatment, the Community Connections Mental Health Court Project, and the Healthy Connections - Integrated Primary and Behavioral Health Care Program The agency offers services tailored to specifically meet the needs of the area's Latino population, including fully bilingual service providers and culturally appropriate treatment GNMHC's Deaf Services Team, the only one in the state, provides mental health services to individuals who are deaf and their families throughout New Hampshire For 45 years, GNMHC has been the designated community mental health center for southern Hillsborough County No other area practice, or hospital service, is dedicated solely, as GNMHC is, to the prevention and treatment of mental illness regardless of its clients' ability to pay GNMHC is the provider with the broadest array of quality services at the lowest, or even no cost, providing critical mental health services to the community's most vulnerable members
