THE DERRYFIELD SCHOOL OPENED ITS DOORS FOR THE 47TH YEAR IN SEPTEMBER 2011 WITH AN ENROLLMENT OF 365 STUDENTS IN GRADES 6-12. THESE STUDENTS CAME FROM 42 SURROUNDING COMMUNITIES WITHIN A 30 MILE RADIUS, AS WELL AS 5 STUDENTS FROM CHINA. THE SCHOOL CELEBRATED THE COMPLETION OF THE GATEWAY BUILDING WITH A RIBBON CUTTING IN MID-SEPTEMBER. THE 8,400 SQUARE FOOT, 1.2 MILLION DOLLAR FACILITY SERVES AS THE "FRONT DOOR" TO THE SCHOOL AND PROVIDES SEMINAR AND CLASSROOM SPACES IN ADDITION TO ADMINISTRATIVE OFFICES FOR ADMISSION, ADVANCEMENT, GLOBAL STUDIES, BUSINESS AND BREAKTHROUGH MANCHESTER. IN OCTOBER, DERRYFIELD COMPLETED THE NEW ENGLAND ASSOCIATION SCHOOLS AND COLLEGE 10 YEAR REACCREDITATION PROCESS. THE NEASC COMMITTEE'S FINAL REPORT INDICATED "EXEMPLARY RATINGS" IN MISSION, FACULTY,
