THE CRISIS INTERVENTION AND SUPPORT SERVICES PROGRAM CONSISTS OF A CONTINUUM OF SERVICES AND SUPPORTS THAT ARE MADE AVAILABLE TO VICTIMS OF DOMESTIC VIOLENCE, SEXUAL VIOLENCE AND STALKING IN THE UPPER VALLEY. WITH THE MISSION OF EMPOWERING VICTIMS OF DOMESTIC AND SEXUAL VIOLENCE, WISE STRIVES TO SUPPORT SERVICE USERS BY PROVIDING THEM WITH INFORMATION AND RESOURCES, HELPING THEM TO FIND THE MEANS TO MAKE INFORMED CHOICES, IDENTIFY THEIR OWN STRENGTHS, AND BUILD THEIR SELF-ESTEEM.
