Information to understand environmental laws and regulations; strategies to encourage industry and government officials to action; referrals to legal, technical, public interest and public health experts; advocating for the public's interest when it comes to Pennsylvania's environment.

We work on the following campaigns:

1. **Campaign to Tackle Gas drilling**: This project works to do the public interest research, educate and inform the public, and give concerned citizens the tools to engage in the growing debate and discussion about Marcellus Shale gas drilling and fracking in the Commonwealth.
2. **Protecting Pennsylvania's Waterways**. This program works to protect Pennsylvania's waterways from both point source and non-point source pollution. Through this project, PennEnvironment Inc. researches the state's worst water polluters, works with legal, scientific and public interest experts to clean up the state's waterways and protect them from further pollution in the future.
