Briefly describe the organization’s mission

The agency has issued more than \$3 billion in bonds to finance homeownership and rental opportunities for low- and moderate-income Vermonters. Over its nearly-37-year history, VHFA has put that money to use helping approximately 27,000 Vermont households to buy a home and financing the development of approximately 8,400 affordable rental units. Loans provided to home buyers and developers typically carry interest rates that are lower than the rates that would be charged by other mortgage funders. This lowers the cost of home ownership and operating rental properties. The flexibility of its financing enables VHFA to collaborate with community land trusts across the state on many of our loans to low- and moderate-income home buyers. This promotes long-term affordability of a portion of Vermont’s housing stock through land trust shared-equity programs. VHFA is primary tool for financing the development of multifamily affordable rental housing is the Low-Income Housing Tax Credit program.
