During the FYE 6/30/2012, IMCI entered into an agreement with the Kevin Durant Family Foundation to act as that organization's fiscal sponsor. The foundation raised about \$648k of revenue which IMCI was paid a percentage for its fiscal management. \$111k of that revenue was deferred to the FYE ending 6/30/13 as it was related to Oklahoma City Thunder player experiences that had not yet been fulfilled as of 6/30/12. The focus of the foundation is to impact after school programs, summer programs, education, and single parents.
