




Since 1971, Health Quarters has provided federal (Title X) and state-funded family planning services and reproductive health care to communities that are among the poorest, most disproportionately HIV-affected, most minority-populated, and most underserved for family planning in Massachusetts, through three offices in Beverly, Haverhill and Lawrence, and subcontracts within Lowell Community Health Center, Lynn Community Health Center, and Salem State University Health Services. Health Quarters' service area encompasses the North Shore and Merrimack Valley, spanning 60 communities in Essex and Middlesex counties. Services include gynecological exams, reproductive health education and youth development programming, and prevention services such as birth control and emergency contraception, cervical and breast cancer screening, STD testing and treatment, and rapid HIV and pregnancy testing and counseling.
