Researching and influencing public policy: staff engage in legislative activities including research, education, legal & policy development on the following issues: 1) Government Spending Transparency: ConnPIRG has researched the government spending websites of various states, compared them on a set of key criteria and issued grades and recommendations for how to make government spending more transparent.
2) Consumer Safety: ConnPIRG provides safety guidelines for consumers when purchasing toys for young children and provide examples of toys currently on store shelves that may pose potential safety hazards.
3) Health Care: American taxpayers spend billions to subsidize junk food ingredients which can cause obesity and other health issues. In contrast, the amount of subsidies given for healthy foods such as fruits and vegetables is only a fraction of that amount.
4) Financial Reform: "The Stop Tax Haven Abuse Act" is a timely and critically important proposal that seeks to stem flight of capital from this country by forcing open and honest accounting of profits. It will put an end to the price and profit shifting that allows companies to engage in such pervasive tax avoidance.
