Latino Project-provides for the improvement of behavioral healthcare for bilingual Latinos and the permanent expansion and enhancement of culturally relevant treatment alternatives for the monolingual population of Connecticut. Funding is provided to five organizations throughout central Connecticut to provide these services.

Tobacco Cessation Program-provides education and support services to adults with serious mental illness interested in reducing or quitting their tobacco use.
