Administer Homeless Management Information System (HMIS) to provide client-level information
to the 46 participating agencies operating 171 programs and adequate data to HUD and the
Oklahoma City and Norman communities on the needs of homeless individuals and families,
the use of services provided by the participating agencies, the progress of individuals, and to enable
sharing of information among agencies to enhance care. Not only does this information
enable these agencies to make decisions based on quantifiable data, federal grants
require the tracking of this data on a community-wide basis. Without this HMIS program
the Oklahoma City and Norman communities would not be eligible to receive federal HUD funding
which would severely hamper the community's ability to provide services to this
vulnerable population. During this year 11,202 persons were entered into the system

Central to the concept of bringing together in one location the resources needed by homeless individuals
and families to navigate the social service system, the coordinated case management
program at WestTown Resource Center is a wholly COLLABORATIVE effort to alleviate
the many logistical challenges, system barriers, and other difficulties faced by
those who are either homeless or at risk of homelessness in achieving sustainable
housing. We bring together existing case managers at multiple agencies that serve the
homeless to form a case manager "dream team", chosen for their experience in various
issues faced by homeless families. The agencies pool their collective resources in order to
help a) prevent homelessness among families with children when possible, b) move
homeless families into housing as quickly as possible, and c) stay in their housing.
