As 2011 was not an election cycle, these political expenditures were directed mainly toward preparation for the 2012 elections. Specifically, the Action Fund developed strategies for the OH-16 race and the New Mexico Senate race. In addition, the Action Fund produced blogs and promoted the Running Clean report which encouraged candidates to run on clean energy and environmental issues. \$48,188 of the total political expenditures was spent on staff salaries (including benefits and overhead), while the remaining \$79,803 was spent on discretionary expenses, including consultants and other vendors, advertising and grants to other organizations. The total amount of political expenditures represents 9 percent of the organization's overall expenditures for the year.
