**Statement of Program Service Accomplishments  
July 1, 2011 through June 30, 2012**

**Volunteer Garden Program to Beautify Liberty State Park**

We again focused on carrying out our beautification and conservation goals, by purchasing trees, plants, shrubs, flowers, and flower bulbs to beautify Liberty State Park.

**Over 5 million people a year visit LSP from around our state, nation and the world and therefore benefit from seeing the attractive plantings and trees throughout this urban waterfront park behind Lady Liberty and Ellis Island.** The beauty of LSP has a positive impact on people's emotional, mental and spiritual health. Our volunteers planted everything, except the trees we funded, and also did a tremendous amount of work in weeding and tree pruning. Plantings were done throughout LSP.

**Funding of Trees** 38 trees in Fall and 75 trees Spring throughout the park

**Saturday 11/ 12 Dr. Frank Gallagher led a guided Nature Walk along the Hudson River Waterfront Walkway and restored natural area from LSP's main part's SW corner to the LSP Caven Point Natural Area beach. (Over 50 people participated).**

**Salt Marsh Clean up 4/14 (17<sup>th</sup> annual)** Over 70 volunteers cleaned up LSP Salt Marsh.

**Group Picnic Pavilions Field completed with help from FOLSP grant (\$142,000, first reimbursement toward \$200,000 grant received this year) from Hudson County - which we conveyed to NJDEP to help construct this \$1.8 million amenity for LSP.**

**Park Festival Participation**

The Friends of LSP has LSP information tables at all major park festivals. We also co-sponsor the Hudson County Earth Day Festival which several thousand people attended.

**36th Birthday Luncheon**

We had our 7th fundraising Recognition Luncheon on May 6, 2012 and it was an inspiring gathering. We honored park leaders and dedicated volunteers. Over 150 people again attended and we had positive publicity in the local newspapers.

**Walk for Liberty State Park 2012**

We co-sponsored our 8th fundraising WALK in LSP on April 21. The Walk's purpose was to raise money to spend on park plantings, etc. and raise public awareness about LSP as a recreational resource. The event was successful as we raised funds from sponsors and from our members who walked and obtained pledges for their walk.

**Mailings to our members of newsletters/postcards and informing public of events.** We informed members and the public about LSP through mailings and newspapers.
