Form 990-EZ, Part I, Line 20 - The filer reduced a grant surplus (earmarked for designated purposes) by spending \$ 932 for the purpose for which the grant was designated.

Form 990-EZ, Part II, Line 26 - Of the funds raised by the filer, some are held as surplus or in reserve for designated purposes, and the net amount of these funds decreased by 932, all of which is attributable to spending down a grant for a multicultural event. Funds held in a reserve account and in a memorial fund held steady.
