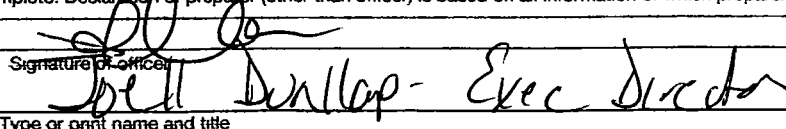

Lines 28, 29, and 30: One of Square Peg's missions is the rescue of horses. Many of the horses rescued by Square Peg have been injured or suffer medical issues. At considerable expense, Square Pegs feeds, houses and cares for the horses (Line 28). Some (4 this FY) of the horses can be re-homed in an suitable environment. Others (that have suitable disposition) are retrained to assist in an adaptive riding program for emotionally, physically and learning disabled children (Line 30). Some adopted horses can be neither retrained nor re-homed". Sanctuary is given to these horses (Line 29). Due to the triple-mission of this organization, all centered around the high cost of feeding, housing and caring for the horses, it is not possible to accurately break out the expenses by mission. Total Program Related expenses (\$135077.50) included HorseCare (\$26733.45), Programs/Camp (\$766.40), Auto Related (\$9919.21), Facilities (\$37706.64) Other (including volunteer costs, staff development, etc) \$8997.71, Payroll (\$50,944.10)
