MONEY RAISED IS USED TO DIRECTLY SUPPORT SERVICESOURCE'S INNOVATIVE PROGRAMS, SUCH AS THE PRINCE WILLIAM NEIGHBORHOOD PLACE, A COMMUNITY-BASED HOME IN WHICH INDIVIDUALS LEARN DAILY LIVING SKILLS SUCH AS COOKING, SHOPPING, MINOR HOME MAINTENANCE AND COMPUTER TRAINING. THE FOUNDATION HAS ALSO FUNDED STATE-OF-THE-ART SENSORY PERCEPTION CENTERS AT SERVICESOURCE'S DAY SUPPORT PROGRAMS, WHICH SERVE MORE THAN 300 INDIVIDUALS WITH SIGNIFICANT DISABILITIES. IN FY 2012, THE FOUNDATION MADE GRANTS TO ENHANCE SERVICESOURCE'S EXPRESSIVE AND EXPERIENTIAL THERAPY OFFERINGS, INCLUDING DANCE, MUSIC AND HORSEBACK RIDING THERAPIES. THE SERVICESOURCE FOUNDATION HAS ALSO FUNDED THE LAUNCH OF THE FAMILY SUPPORT NET INITIATIVE. IN FY 2012, SERVICESOURCE INITIATED BETA TESTING OF THE FAMILY SUPPORT NET SOFTWARE APPLICATION, A WEB-BASED RESOURCE DESIGNED TO PROVIDE INDIVIDUALS AND THEIR FAMILY MEMBERS WITH THE TOOLS AND SUPPORTS NEEDED TO ORGANIZE RESOURCES AND ENHANCE INDEPENDENCE AND QUALITY OF LIFE. THE FAMILY SUPPORT NET OFFERS A SEAMLESS RELATIONSHIP AMONG THREE CORE SUPPORTS: A WEB-BASED PLANNING AND INFORMATION GATHERING TOOL, THE COORDINATION AND DELIVERY OF INDIVIDUALIZED DIRECT SERVICE SUPPORTS, AND BENEFITS PLANNING WITH AN EMPHASIS ON FINANCIAL STABILITY AND SECURITY FOR THE FUTURE. IN ADDITION, THE SERVICESOURCE FOUNDATION CONTINUES TO SPONSOR SERVICESOURCE'S ANNUAL SERVICE EXCELLENCE AWARDS PROGRAM, IN WHICH SERVICESOURCE PROGRAM PARTICIPANTS AND EMPLOYEES WITH DISABILITIES ARE RECOGNIZED FOR THEIR ACHIEVEMENTS. THE FOUNDATION RAISES MONEY THROUGH COMMUNITY OUTREACH ACTIVITIES AND EVENTS SUCH AS THE ANNUAL SPRING WINE FEAST IN WASHINGTON, DC. THE SERVICESOURCE FOUNDATION IS A SEPARATE 501(C)(3) ORGANIZATION GOVERNED BY A VOLUNTEER BOARD OF TRUSTEES. THE FOUNDATION RAISES MONEY IN SUPPORT OF SERVICESOURCE - AN AFFILIATION OF FIVE NOT-FOR-PROFIT 501(C)(3) ORGANIZATIONS GOVERNED BY A COMMON MEMBER VOLUNTEER BOARD OF DIRECTORS. THE FIVE REGIONAL OFFICES REMAIN SEPARATE LEGAL ENTITIES BUT ARE COMMONLY BRANDED AS "SERVICESOURCE." GENERAL CORPORATE AND OVERHEAD EXPENSES AND SALARIES ARE SPREAD ACROSS ALL REGIONAL OFFICES ACCORDING TO APPROPRIATE ALLOCATION METHODOLOGY AND BASED ON THE PERCENTAGE OF SUPPORT TO THE SPECIFIC REGIONAL OFFICE. THIS STRUCTURE ALLOWS FOR MAINTENANCE OF MUCH LOWER CORPORATE OVERHEAD RATE AS A PERCENTAGE OF REVENUE TO ENSURE THAT ADEQUATE FUNDS ARE DIRECTED SPECIFICALLY TO PROGRAM OPERATIONS. IN ADDITION TO THE VIRGINIA REGIONAL OFFICE FOR REHABILITATION AND EMPLOYMENT SERVICES IN ALEXANDRIA, VIRGINIA, OTHER OFFICES INCLUDE THE VIRGINIA REGIONAL OFFICE FOR HABILITATION SERVICES IN SPRINGFIELD, VIRGINIA, THE FLORIDA REGIONAL OFFICE IN CLEARWATER, FLORIDA, THE NORTH CAROLINA REGIONAL OFFICE IN FAYETTEVILLE, NORTH CAROLINA, AND THE DELAWARE REGIONAL OFFICE IN WILMINGTON, DELAWARE. WITH OPERATIONS IN NINE STATES AND THE DISTRICT OF COLUMBIA, SERVICESOURCE COLLECTIVELY EMPLOYED MORE THAN 1,500 PEOPLE WITH DISABILITIES AND PROVIDED EMPLOYMENT AND OTHER SUPPORT SERVICES TO MORE THAN 14,000 INDIVIDUALS IN FY 2012. THE FIVE REGIONAL OFFICES SHARE A MISSION OF PROVIDING EXCEPTIONAL SERVICES TO INDIVIDUALS WITH DISABILITIES THROUGH INNOVATIVE AND VALUED EMPLOYMENT, TRAINING, HABILITATION, HOUSING AND SUPPORT SERVICES.
