HALO MEETS EMERGENCY SHELTER NEEDS FOR ALL MEN, WOMEN, AND CHILDREN WHO ARE EXPERIENCING HOMELESSNESS, COORDINATES SUPPORTIVE SERVICES THAT HELP HOMELESS ADULTS BECOME SELF-SUFFICIENT, PROVIDES COMMUNITY LEADERSHIP TO PREVENT CHRONIC HOMELESSNESS, AND ENSURES CHILDREN GET POSITIVE SUPPORT THROUGH STABLE LIVING AND LEARNING ENVIRONMENTS. HALO LEASES INDEPENDENT APARTMENTS IN RACINE FOR FAMILIES TRANSITIONING FROM HOMELESSNESS TO INDEPENDENCE.
