### Bright Futures Accomplishments for Fiscal Year 2011-12

Bright Futures operates a child care resource and referral service for Montrose, Delta, San Miguel and Ouray counties. This fiscal year we had 34 phone referrals and 128 internet referrals to help parents find quality child care in their area. Bright Futures (BF) also provided 14 teacher trainings and 167 child care providers attended so they could get 15 hours each continuing education required by state licensing.

Bright Futures home tutoring program for parents and children ages birth to 5 called Parents as Teachers (PAT) had 51 families participate this fiscal year. 569 home visits were conducted for 73 children to prepare them for success on their first day of kindergarten. The parents also gained parenting skills.

Bright Futures raised \$150,000 toward the building of a child care facility at the east end of Telluride. The Gold Run Early Learning Center is currently under construction and slated to open January 2013. This will provide quality care and education for the working class parents of San Miguel County.

Bright Futures also provides providers with educational stipends to further their education in early childhood. BF also provides financial assistance to providers for educational materials. During the last fiscal year Bright Futures awarded \$9,701 to providers.
