28 A total of twenty-five (25) Classes/Trainings and workshops were held. These included basic through intermediate level computer literacy classes, office applications, and information and communications (ICTs) technical training classes. In addition, the organization presented a total of 133 certificates of course completion and participation to those meeting the minimum requirements for attendance, assessment/quiz /test scores, and completion of class projects and/or presentations. Our goal was to serve a minimum of 75 individuals (including youth and adults). The actual number of unduplicated people served was one hundred and fifteen (115). The following is a demographic breakdown of those served: Demographics: 100% poor and low income individuals served, 84% African Americans served, 13% Hispanic/Latino served, 44% males served, 56% females served, 9% under age 18 served, 63% ages 26-61 served, 27% age 62 and older served (Grants \$ 103,080).
