Asylum Access was founded to make refugee rights a reality in Africa, Asia, and Latin America. We achieve this through an innovative model that uses five tools to transform the human rights landscape for refugees in first countries of refuge: individualized legal counsel and representation, community legal empowerment, policy advocacy, strategic litigation, and movement-building.

Individualized Legal Counsel and Representation: Asylum Access provided legal information, advice, and/or representation to over 5,000 refugees in Ecuador, Thailand, and Tanzania to empower refugees to assert their fundamental rights to safety, move freely, work, send their children to school, access healthcare and financial institutions, and take other steps to rebuild their lives.

4b (Code:) (Expenses \$ 124,888 including grants of \$ 0) (Revenue \$ 0)

Policy Advocacy: Asylum Access continued to advocate for improved refugee rights practices. Among other successes, we convinced the government to draft a law that would grant temporary asylum to Thailand's 142,000 refugees, protecting them from detention in conditions called "tantamount to torture" and deportation back to countries where they may be raped, tortured, or killed.

Movement Building: Asylum Access is committed to advancing the global refugee rights movement. This year, we launched a prototype of the Refugee Rights Toolkit, an office-in-a-box designed to enable refugee rights advocates to replicate our model anywhere in the world. The Toolkit is now being tested by pilot users, with a final version planned for public release by 2015.

Community Legal Empowerment - Expenses: \$ 36, 216

Asylum Access trained refugees to understand and assert their fundamental human rights. This included one-time Know Your Rights trainings; training of refugee community leaders as Community Legal Advisors capable of providing legal information and referrals within their communities; and training of multilingual refugees as interpreters capable of providing professional interpretation services so that refugees can access justice in a language they can understand.

Strategic Litigation - Expenses: \$ 17,258

Asylum Access engaged in litigation in national courts in Ecuador and before the Inter-American Commission on Human Rights to secure refugees' release from unlawful or unjustified detention, to demand that the state protect women refugees from sexual or gender-based violence and investigate incidents of sexual or gender-based violence against women refugees, and to advance other refugee rights.

Part VI, Governance, Management and Disclosure

The Board of Directors is made up of independent elected members that are influential members of business and society. Asylum Access uses this structure as an overall strategic level of management, leaving the day-to-day operations of the organization to the Executive Director. The number of voting members of the Board increased to five members during the fiscal year ending June 30, 2012. Remuneration for the Executive Director is determined by the Board at Board meeting(s). Board discussions are recorded as meeting notes for future reference.

Form 990 and all required schedules are shared with all Officers and Directors via email at the time of filing. The form and all schedules were prepared by the Executive Director. All Directors are expected to review the form and schedules upon receipt. Any necessary discussion of the form or schedules will take place at the first Board meeting subsequent to filing.

Directors and leadership employees are expected to disclose any conflict of interest. Any disclosures are recorded in writing, email correspondence or Board meeting notes.
