1. Organization and Operations

Superior Direct Care, Inc. ("Superior") commenced operations on July 1, 2005 and provides temporary well trained, qualified direct care staff to agencies within the five boroughs of New York City and is exempt from income taxes under 501(c)(3) of the Internal Revenue Code.

2. Summary of Significant Accounting Policies

Revenue

Superior reports service revenue at the estimated net realizable amounts from patients, third party payors and others for services rendered.

Cash

Superior maintains cash in a bank account which, at times, may exceed federally-insured limits. Superior has not experienced any losses in such account.

Receivables

Accounts receivable consists of amounts due for direct care services. Accounts receivable are periodically evaluated for collectibility based on past credit history and their current financial position. Changes in the estimated collectibility accounts receivable are recorded in the results of operations for the period in which the estimate is revised. Accounts receivable that are deemed uncollectible are offset against the allowance for doubtful accounts.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Basis of Presentation

Superior reports information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets and permanently restricted net assets. Contributions received are recorded as unrestricted, temporarily restricted or permanently restricted support depending on the existence and/or nature of any donor restrictions. There were no temporarily or permanently restricted net assets as of June 30, 2012 and 2011.

However, the receipt of any restricted contributions whose restrictions expire, or are otherwise satisfied within the period of receipt, are reported as unrestricted revenues in the statement of activities.

Reclassifications

Reclassifications were made to the 2011 financial statements to conform to the 2012 presentation.

3. Related Party Transactions

Due from affiliate represents non-interest bearing advances with no stated repayment terms between Superior and NYSARC, Inc., New York City Chapter ("AHRC"). Superior and AHRC are related in that AHRC is the sole member of Superior and the beneficiary of Superior's surplus funds, if any.

Included in revenue is \$7,011,166 and \$6,799,750 charged to AHRC for home health services for the years ended June 30, 2012 and 2011, respectively. There were no accounts receivable related to AHRC at June 30, 2012 and 2011.

Included in general and administrative expenses are management fees of \$684,231 and \$693,395 for the years ended June 30, 2012 and 2011, respectively, charged by AHRC. Shared building expenses of \$46,439 and \$48,816 are also included in general and administrative expenses for the years ended June 30, 2012 and 2011, respectively.

4. Major Customers

Three unrelated customers accounted for approximately 100% and 97% of the accounts receivable balance at June 30, 2012 and 2011, respectively.

5. Income Taxes

Superior is organized under the not-for-profit corporation law of the State of New York. Superior has been granted exemption from Federal income tax pursuant to Section 501 (c)(3) of the Internal Revenue Code. Superior is current with respect to its Federal and State income tax filing requirements. Management is not aware of any issues or circumstances that would unfavorably impact its tax exempt status. Management has determined that Superior had no uncertain tax positions that would require financial statement recognition. Superior is no longer subject to audits by the applicable taxing jurisdictions for the periods prior to 2008.

6. Subsequent Events

Superior has evaluated subsequent events through December 4, 2012, the date the financial statements were available for issuance.
