

After School Homework Program is an afternoon program staffed by T/E teachers, instructional assistants and school counselors who assist students in developing good study skills and completing homework and projects. General academic assistance, homework help, recreation and social interaction are provided. The program is offered four days/week at all elementary and middle schools in the district. A snack is available for each student and bus transportation is provided to the student's home. Students are invited to participate in this program based on the student's academic, economic, and social/emotional needs.

4b (Code:) (Expenses \$ 30,949. including grants of \$ 0.) (Revenue \$ 0.)

Delaware Valley Friends School Summer Reading Program is a 5 week reading camp for middle and high school students who struggle to read at grade level and have an environmental (typically economic) barrier that prevents them from being able to attend the program on their own. This summer program provides intense, consistent, individualized reading instruction. Students come away with better reading skills, improved self-confidence and a better attitude toward school.

4c (Code:) (Expenses \$ 26,300. including grants of \$ 0.) (Revenue \$ 0.)

Green Valley Academy Summer Academic Program is a summer program for rising 4th through 8th graders. The mission of the program is to rediscover and advance the basic skills of Math, Science, Social Studies, Writing, Reading and Social Skills. The 4 day classes are taught by certified teachers over a 5 week period. FLITE scholarships are provided to students who have an environmental (typically economic) barrier that prevents them from being able to attend the program on their own.
