THE ORGANIZATION WAS FORMED TO HELP FAMILIES IN NEED DUE TO THE EFFECTS OF A NATURAL DISASTER. SPECIFICALLY BUT NOT LIMITED TO: PROVIDING ASSISTANCE TO FAMILIES FOR BOOKS, TUITION AND OTHER SCHOOL RELATED EXPENSES.
