The Chapel is open daily for all those who seek refuge for peaceful reflection and prayer. The Chaplain's office strives to promote faith development, personal reflection, and religious understanding; an increase in programs was realized in Fiscal 2012. The Chapel also offers numerous opportunities for students to participate in community service activities. An example of activities included Remembrance Service, Festival of Lights, religious retreats, Endicott Christian Fellowship and Women's Christian Fellowship Group. A Chaplain's Advisory Committee was formed the prior year to assist the Chaplain in planning religious programming for the community. Interfaith services were also offered. The Endicott College Community Service Program is affiliated with the Chapel, and many activities are co-sponsored. Volunteer programs included Day of Daring, Relay for Life, Habitat for Humanity, to name a few.
