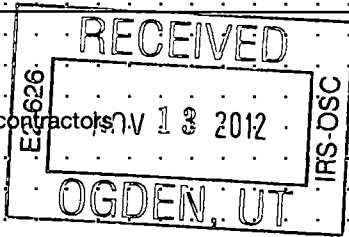

Part I #10 - \$50,000 was paid out during the course of the year to Cambridge Leadership Associates, LLC (215 Park Avenue S., Suite 1902, New York, NY 10003) for the Adaptive Leadership Program for the Common Course Standards Initiative. Cambridge Leadership assisted administrators in Kent County to learn and support leadership development for transformational change. \$10,500 was paid out in a grant to Kent Intermediate School District (2930 Knapp Street, NE, Grand Rapids, MI 49525) for Bright Beginnings. These dollars were to assist Bright Beginnings in the start up of a new program through Kent Intermediate School District for preschool age children. \$7,430 was paid in scholarships for five Board Members from local Kent County school districts to attend the Federal Relations Network Conference in Washington, DC. The remaining \$6,171 were grant fund expenditures under \$5,000.

Part I #16 - Other expenses totaled \$29,075. The majority of these expenses were for meeting expenses, including room rentals, meals, lodging for retreats, entrance fees, etc. This includes meetings for the Kent Intermediate Superintendents' Association, Kent Intermediate Association of School Boards, Kent Change Leadership, Kent Learning Collaborative, Interfaith Student Fellows Program and Bright Beginnings. \$2,500 were spent on rental space for the movie premiere and miscellaneous expenses for the special education students and teachers the movie was based on. There was also a \$20 expense included for the Nonprofit Corporation Filing Fee and \$952 spent on various memorial contributions and recognitions.

Part III #31 - The "other program services" included \$7,430 paid out as grants (scholarships) for five Board Members from local Kent County school districts to attend the Federal Relations Network Conference in Washington, DC, a grant of \$2,672 raised for Special Olympics by a movie premiere of "A Smile As Big As the Moon", and \$2,400 paid to a charter school that was donated specifically as a grant for them. The Kent Intermediate Association of School Boards which lead education improvement throughout the Kent Intermediate School District that affects approximately 130,000 children in Kent County spent an additional \$3,065 on meeting expenses including meals, copies, and room charges. \$3,347 were spent on meetings for Kent Learning Collaborative which is a group of administrators working collaboratively to keep curriculum in school districts updated for approximately 130,000 children in Kent County. \$1,218 were spent on the Interfaith Student Fellows Program for meeting entrance fees and meals. \$2,500 were spent on rental space for the movie premiere and miscellaneous expenses for the special education students and teachers the movie was based on.
