To alleviate poverty and promote social justice by strengthening women-led development initiatives and creating access to the U.S. market for marginalized communities across the world. This past year in addition to selling direct to consumers through our e-commerce site, we greatly expanded our wholesale and custom markets. We now sell products in hundreds of stores across the country, and in early 2012 we developed a line of products for a large international retailer. This past year, we designed and implemented a monitoring and evaluation system to measure the impact of our work on our partners' lives. We awarded several capacity-building grants to our global partners to fund projects throughout the year, which include expanding and renovating bathroom facilities in a home for pregnant adolescents in Peru, partnering with Guatemalan women to purchase smokeless stoves and water filters to keep their families healthy, and expanding training and employment opportunities in the Yucatan, Mexico.
