Pride Academy Charter School commenced implementation in the 2008-2009 school year and has just completed its fourth year of operation. The school's charter authorized a maximum enrollment of 240 students in Grades 5-8. The enrollment at the beginning of the school year was 240 students. At the end of the year the enrollment was 240 students. There are three classes each of Grades 5, 6, 7, and 8, with class sizes of 20 students per class. It is anticipated that enrollment will increase to 264 students for the upcoming school year. During the 2011-2012 school year, the Charter School's Administrative team continued to lead the growth and strengthening of the school in the fourth year of operation. One of the highlights in accomplishments was to develop and implement an extracurricular and after school program that offers a wide range of athletic, academic, and culturally enriching activities and experiences that included chess, yearbook, cheerleading, basketball, soccer, flag football, speed stacks, robotics, MVP male empowerment, and book clubs.
