	Georgian Court University serves nearly 2,500 students in 30 undergraduate and 9 distinctive graduate programs Students are enrolled through the GCU School of Business, School of Education and the School of Arts and Sciences The university also has mounted a growing online program offering graduate degrees in holistic health and homeland security that are taught in a complete virtual environment Georgian Court, located in historic Lakewood, N J , is dedicated to the personal and professional success of its students The university has historic roots as a womens college, but has served male students in evening and graduate courses since the 1970s In May 2012, GCU announced that it would become fully co-educational by the fall of 2013 The university provides a values-based liberal arts education that enhances the marketability of GCU graduates across various disciplines and emphasizes purposeful leadership that enables graduates to excel in their careers while contributing to the greater good of their communities, state and nation GCUs 13 1 student-faculty ratio facilitates unique learning relationships on the graduate and undergraduate levels, and is especially helpful for adult learners who are interested in GCUs accelerated programs, who have busy schedules, job and family obligations, or have limited time to attend class In recent years, GCU has added new areas of study that reflect employment trends In May 2012 the university graduated 30 new nurses, the first group to matriculate through the GCU-Mendian Health School of Nursing The university also has added degrees in recent years in such high-demand areas as homeland security, holistic health, exercise science, dance, psychiatric rehabilitation and psychology, and applied behavior analysis---all of which address growing needs in the marketplace Also, GCU specialty offerings in autism spectrum disorders, Pre-K to 3rd education, sustainability, graphic design & multimedia, and the universitys 52-week M B A mirror the demands of growth industries in New Jersey and beyond GCU gives students an exceptional learning environment where they conduct research with faculty and gain valuable experience in their disciplines before graduation Students often work alongside faculty mentors in social work, biochemistry, neurobiology, autism studies, early childhood education, learning disabilities consulting, and school psychology Those studying criminal justice, dance, exercise science, and business are equally as involved Georgian Court University prepares students for life beyond the campus gates By senior year, 61% of students have participated in some type of practicum, internship, field experience, co-op, or clinical assignment In addition, 74% of students have participated in community service or volunteer work by their senior year Not only are GCU graduates going off to work for major corporations, school districts, and hospitals, but 45% go on to further their education The university also extends educational opportunities to senior adults through the McAuley Institute for Lifelong Learning (MILL) The program, launched in 2009, has grown from two pilot courses to more than 40 classes that cover subjects ranging from Italian art, history and politics to computer technology, social networking, and memoir wnting Since its founding, MILL has registered more than 500 seniors, ages 50 and older, for non-credit, college-level courses taught by faculty STUDENT NEED AT GCU About 99 percent of GCU's full-time first-year students receive aid with an average financial aid package of \$30,150 Since 2005, the percentage of full-time freshmen receiving Pell grants (federal aid) has nearly doubled, nising from 32% to 59% of students In addition, 46% of freshmen in the class entering GCU in fall 2011 were first-generation students For prospective and current Georgian Court students, paying for college is the single biggest roadblock to pursuing a degree However, with adequate financial support, Georgian Court students succeed in the classroom Georgian Court is not a typical institution because its high volume of commuter, graduate students, non-traditional students and Communniversity students (who take courses at an off-campus site) all contribute to school pride in ways that a university with a larger body of resident students is more apt to have

	STUDENT-ATHLETES AT GCU As a member of the Central Athletic Collegiate Conference, Georgian Court University fields 125 athletes in nine NCAA Division II sports, including basketball, cross country, lacrosse, soccer, softball, volleyball, tennis, and both indoor and outdoor track & field The GCU athletics program is distinguished by its commitment to building well-rounded athletes who achieve on the field and in the classroom In keeping with their peers nationally, GCU student-athletes cultivate leadership skills in their individual sports and in their classroom and community involvement The teams are very active in the community, as well, and have raised money for the Susan B Komen Walk for the Cure, Make-a-Wish Foundation, National Girls and Women in Sports Day, and the Tournament of Champions while supporting fundraising for cystic fibrosis and multiple sclerosis research In addition, students regularly host sports clinics for area youth
