The compensation of an employee is reviewed and approved using data as to comparable compensation for similarly qualified persons in functionally comparable positions. 3) Contemporaneous documentation and recordkeeping with respect to deliberations and decisions regarding compensation arrangement are contained in Board minutes, personnel employment processing documents or associated collective bargaining unit contracts. The process was last undertaken to establish compensation for the President in 2007 and other key employees in 2008.
