RESIDENTS OF LUCY'S HEARTH'S EMERGENCY SHELTER, SUPPORTIVE HOUSING PROGRAM-TRANSITIONAL APARTMENTS AND PERMANENT APARTMENT PROGRAMS PARTICIPATE IN PARENTING AND LIFE SKILLS, GED CERTIFICATE (HIGH SCHOOL EQUIVALENCY), AND FINANCIAL MANAGEMENT CLASSES, AS WELL AS RECEIVING REFERRALS TO OUTSIDE PROVIDERS FOR HIGHER EDUCATION, TRAINING, MEDICAL CARE, AND ADDITIONAL MENTAL HEALTH TREATMENT. RESIDENTS ARE REQUIRED TO PARTICIPATE IN SHELTER SERVICES DURING THE YEAR, 44 MOTHERS AND 80 CHILDREN RECEIVED SERVICES THROUGH LUCY'S HEARTH'S EMERGENCY SHELTER, SUPPORTIVE HOUSING PROGRAM-TRANSITIONAL APARTMENTS AND PERMANENT APARTMENT PROGRAMS, FOR A TOTAL OF NEARLY 10,000 SHELTER AND TRANSITIONAL BED NIGHTS AND NEARLY 23,000 MEALS SERVED. LUCY'S HEARTH'S OUTREACH AND AFTERCARE PROGRAM USUALLY SERVES 50 MOTHERS AND 100 CHILDREN OVER THE COURSE OF A YEAR. THE TYPICAL LENGTH OF STAY FOR THE EMERGENCY SHELTER PROGRAM IS THREE TO SIX MONTHS. WITH RESIDENTS STAYING IN THE SUPPORTIVE HOUSING PROGRAM-TRANSITIONAL APARTMENTS FOR UP TO TWO YEARS. FOLLOWING EMERGENCY SHELTER AND SUPPORTIVE HOUSING PROGRAM-TRANSITIONAL APARTMENT SERVICES, RESIDENTS RECEIVE ABOUT SIX MONTHS OF OUTREACH AND AFTERCARE PROGRAMMING FOR THE SUPPORTIVE HOUSING PROGRAM-TRANSITIONAL APARTMENTS, LUCY'S HEARTH HAS APARTMENTS IN VARIOUS NEWPORT COUNTY LOCATIONS. THE PROGRAM ASSISTS MOTHERS AND THEIR CHILDREN TO OVERCOME BARRIERS TO LIVING ON THEIR OWN AND THE EMPHASIS IS SELF-SUFFICIENCY. TO BE ELIGIBLE FOR THIS PROGRAM, MOTHERS MUST HAVE SUCCESSFULLY COMPLETED THE EMERGENCY SHELTER PROGRAM, AND BE WORKING OR GOING TO SCHOOL. PROGRAM PARTICIPANTS CONTINUE TO PARTICIPATE IN LIFE SKILLS EDUCATION AS WELL AS CASE MANAGEMENT IN THEIR APARTMENT ON A WEEKLY BASIS. IF NEEDED, MOTHERS AND THEIR CHILDREN MAY STILL RETURN TO THE EMERGENCY SHELTER PROGRAM TO PARTICIPATE IN PROGRAMS AND SERVICES FOR THE PERMANENT APARTMENT PROGRAM, LUCY'S HEARTH PROVIDES PERMANENT SUBSIDIZED HOUSING THROUGH THE "ROADHOME" PROGRAM FROM RHODE ISLAND HOUSING. THESE APARTMENTS ARE AVAILABLE FOR LUCY'S HEARTH RESIDENTS WHO REQUIRE LONG-TERM STABILIZATION. SERVICES THE OUTREACH AND AFTERCARE PROGRAM REFLECTS LUCY'S HEARTH COMMITMENT TO ENSURING ITS RESIDENTS AVOID FUTURE HOMELESSNESS. FORMER RESIDENTS OF ANY LUCY'S HEARTH PROGRAM MAY RECEIVE, FOR UP TO SIX MONTHS, CASE MANAGEMENT, CRISIS INTERVENTION, BUDGETING ASSISTANCE, REFERRALS TO COMMUNITY PROVIDERS, AND ADVOCACY TO ASSIST IN ACCESSING COMMUNITY RESOURCES OR TO TROUBLE-SHOOT ISSUES THAT MAY ARISE. IN 2011, FOR THE FIRST TIME IN ITS HISTORY, LUCY'S HEARTH WAS ACCREDITED BY THE COUNCIL ON ACCREDITATION.
