The Outpatient Clinics serve adults age 18 and over who have mental
health or substance abuse problems. In addition to the outpatient
level of care, which provides assessments, individual and group
therapy as well as medication management as needed. The clinics
offer Intensive Outpatient programs for individuals with
Co-occurring substance abuse and mental health problems. Walk in
crisis and mobile crisis services are provided. The objective of the
clinics are to provide recovery orientated services by helping
clients manage their symptoms to achieve their life goals. During
F/Y 6/30/12 the clinics treated 2,188 unduplicated clients.

4b (Code _____) (Expenses \$ 991,171. including grants of \$ 0.) (Revenue \$ 262,142.)

The umbrella program provides a safe and confidential environment for
victims of domestic violence and their children, giving them the
opportunity to access supportive services anytime they are in need of
those services. A domestic violence shelter is provided for victims at
risk. The goal of the program is to provide supportive services that
empower people to make positive and productive changes/choices in
their lives to free themselves from the cycle of violence. Children
are also provided with a range of comprehensive services including
counseling and advocacy. During the year, approximately 2,000 victims
were served.

Community Support Services provides goal orientated and individualized
supports focusing on improved self-sufficiency for persons served
through assessment, planning, linkage, advocacy, coordination and
monitoring activities. The intensity of the services provided is
based on the needs of the persons served. Clients are encouraged
to live their lives as independently as possible. During the year
509 individuals were served.
