The Finance Director will perform a detailed review of the Form 990, present it the senior management team, and propose any revisions needed. The Executive Committee will then review the revised Form 990 before filing.

Each Board member completes a conflict of interest policy annually.

The Personnel Committee and Executive Director worked with an outside consultant to develop salary bands for each position based on industry standards, comparability data, and job descriptions. The Executive Committee set the Executive Director's salary. The Executive Committee and Executive Director set the Senior Management team's salaries. Proposed salaries for all other employees were developed by the Executive Director and Senior Management team. These salaries were presented to the Personnel Committee for approval and were then approved as part of the total operating budget by the Board of Trustees.
