Shelter Program: In the 2012 Fiscal Year, the shelter program housed 136 individuals for a total of 7,256 nights. Of those clients that left the program, 41 individuals were able to move to apartments without the assistance of a subsidy. An additional 21 clients moved in with family and friends and 17 clients were able to find placement in a transitional housing program. Of those clients that left the shelter program, 56 were able to secure employment income. WARM also received 270 calls looking for shelter.

4b (Code) (Expenses \$ **195,362** including grants of \$) (Revenue \$ **62,602**)
Harvest Homes: In the 2012 Fiscal Year, the Harvest Homes program took in 11 families which consisted of 18 adults and 18 children. The Harvest Homes program provided 11,166 overnights to families that would have otherwise been homeless.

Outreach: In the 2012 Fiscal Year, the WARM's outreach program was able to serve 112 households. This consisted of 228 adults and 169 children. In total, WARM distributed \$23,239 to these families in the form of financial assistance for rent, utilities, hotel/motel vouchers, and prescriptions.
