Community Action and Development ProgramsIn every county in New Jersey, the State designates official Community Action Agencies (CAA) In 2009, the Jewish Renaissance Foundation, Inc (the Organization) was designated by the State as the official CAA for Middlesex County East Although most Organization programs continue to benefit residents throughout Middlesex County, its state-funded CAA programs are provided specifically for qualified residents in eight designated communities Carteret, Edison, Highland Park, Metuchen, Perth Amboy, Sayreville, South Amboy and Woodbridge As a CAA, the Organization helps qualified people attain economic self-sufficiency The Organization also provides emergency services to meet immediate needs, while fostering individual growth and transition to household stability Qualifying households in need of emergency assistance can obtain help through the following four programs food assistance, rent/mortgage assistance one time in a fiscal year for households with at least two months behind in rent or mortgage with the capacity to meet minimum payment of \$25 toward the debt before assistance and able to demonstrate an ability to pay independently going forward, and utilities assistance during the months of June through October for households who received a shut-off notice from the utility company, or be more than \$500 in arrears on utility payments, and able to demonstrate an ability to pay going forward Through collaboration, consortiums and alliances, the Organization also demonstrates its commitment to community development specifically for the Greater Budapest neighborhood With a comprehensive neighborhood revitalization plan (the Plan) put together by various community stakeholders, the Organization is committed to implementing the Plan which included the following main components (1)Create a sense of place and foster community engagement, (2)Develop affordable housing, (3) Ensure better access to social services, especially medical health services, (4) Increase after-school activities and create better recreational opportunities, (5) Create economic opportunity, (6) Provide job training for youth and adults, (7) Make improvements to the Amboy Avenue business district, (8)Provide assistance to existing businesses and to those who wish to be entrepreneurs, (9) Ensure public safety, and (10) Park and Recreation improvement Community action and development programs are funded through federal, state and community grants and contributions
