THE ALEXANDER DAWSON SCHOOL IN BOULDER COUNTY, COLORADO, A \$33.5 MILLION FACILITY BUILT BY THE ALEXANDER DAWSON FOUNDATION IN 1970, PROVIDES A RIGOROUS, COLLEGE PREPARATORY EDUCATIONAL PROGRAM THAT CHALLENGES 460 STUDENTS IN KINDERGARTEN THROUGH GRADE 12 TO ACHIEVE EXCELLENCE IN MIND, BODY, AND CHARACTER DURING THE 2011-2012 SCHOOL YEAR. THE SCHOOL PROVIDED \$1,194,970 IN FINANCIAL AID TO 84 DESERVING AND TALENTED STUDENTS WHO OTHERWISE WOULD NOT HAVE BEEN ABLE TO AFFORD A DAWSON EDUCATION. IN JUNE 2012, THE SCHOOL AWARDED DIPLOMAS TO 44 GRADUATES, WHO WERE ACCEPTED TO SUCH COLLEGES AS THE UNIVERSITY OF NOTRE DAME, DARTMOUTH COLLEGE, CALIFORNIA POLYTECHNIC STATE UNIVERSITY, VASSAR, UNIVERSITY OF CALIFORNIA, BOSTON UNIVERSITY, PRINCETON, AND THE UNIVERSITY OF ROCHESTER AND WHO WERE OFFERED \$4.2 MILLION IN SCHOLARSHIPS. IN ADDITION, THE SCHOOL OWNED AND OPERATED A SUMMER CAMP IN 2011 THAT OFFERED INSTRUCTION AND ACTIVITIES IN MUSIC, SPORTS, ACADEMICS, ART, DRAMA, TECHNOLOGY, ENGINEERING AND SCIENCE FOR 1,461 BOYS AND GIRLS.
