THE GRANT IS DESIGNED TO INCREASE THE NUMBER OF CLINICAL HOURS AT THE MID-VALLEY PRIMARY CARE CLINIC LOCATED IN ARCHBALD, PENNSYLVANIA, AS WELL AS INCREASE THE PRIMARY MEDICAL WORK FORCE IN LOW-INCOME CARBONDALE FEDERALLY DESIGNATED PRIMARY CARE HEALTH PROFESSIONAL SHORT AREA #142999423W AND FOUR ADJACENT MEDICALLY UNDERSERVED AREAS IN LACKAWANNA, WAYNE, LUZERNE AND SUSQUEHANNA COUNTIES. CLINICAL RESEARCH - TRACER. THE ORGANIZATION PERFORMS CLINICAL TRIAL RESEARCH STUDIES UNDER THE THROMBIN RECEPTOR ANTAGONIST FOR CLINICAL EVENT REDUCTION IN ACUTE CORONARY SYNDROME ("TRACER") GRANT AGREEMENT FOR THE CARE AND TREATMENT OF SUBJECTS WITH ACUTE CORONARY SYNDROME. HEALTH INFORMATION EXCHANGE ("HIE"). DURING 2011, THE ORGANIZATION RECEIVED A \$95,000 GRANT FROM THE COMMONWEALTH OF PENNSYLVANIA DEPARTMENT OF WELFARE UNDER ITS HIE PORTAL TO FACILITATE HEALTHCARE DELIVERY SYSTEM TRANSFORMATION PROGRAM.
