

RECREATION SERVICES - ASNC OPERATES CAMP ROYALL, AN OVERNIGHT WEEK-LONG CAMP PROGRAM FOR CHILDREN AND ADULTS FOR 10 WEEKS DURING THE SUMMER. THROUGH CAMP ROYALL, ASNC ALSO PROVIDES WEEKEND RESPITE PROGRAMS THROUGHOUT THE YEAR FOR INDIVIDUALS AND THEIR FAMILIES. FOR MANY FAMILIES, THE TIME THAT THEIR CHILD SPENDS AT CAMP ROYALL IS THE ONLY RESPITE CARE THEY RECEIVE DURING THE YEAR. CAMP ROYALL ALSO PROVIDES HANDS-ON TRAINING FOR COLLEGE-AGED COUNSELORS EACH SUMMER WHICH BUILDS THE SKILLS AND ATTITUDES NECESSARY FOR THEM TO GO ON TO LIFE-LONG CAREERS SERVING PEOPLE WITH AUTISM.
