CODE OF REGULATIONS OF
THE SPRINGFIELD CATHOLIC CENTRAL SCHOOL FOUNDATION
AS AMENDED MAY 16, 2012

ARTICLE 1

Legal Status and Purpose

Legal Status. The Corporation is intended to be, and shall be operated and conducted as an organization which is exempt from the federal income taxation under Internal Revenue Code Section 501(c)(3). No member of the Corporation shall have any right, title or interest in or to the whole or any part of the property or assets of the Corporation, and no member shall be entitled to either the whole or any part thereof in the event of the termination of his membership in the Corporation; provided, however, that in the event the Corporation is dissolved, the property and assets of the Corporation shall be distributed as instructed in the Articles of Incorporation.

Purpose. The purpose for which the Corporation is formed is to support Catholic schools in the Clark / Champaign County area and afford students and their families the means to attend Catholic Central School, without regard to race, color, national origin or sex. The Corporation may engage in any lawful activity subject to the following:

The purpose of the Corporation shall be exclusively charitable, scientific, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code, as currently in effect or as the same may be amended or replaced from time to time.

The Corporation shall be organized and operated as an organization which is other than a private foundation (within the meaning of Internal Revenue Code Section 509(a)).

The Corporation is not for profit and shall not afford pecuniary gain, incidentally or otherwise, to its members. No part of the net earnings shall inure to the benefit of its Trustees, officers, members, or other private individuals, except that the Corporation may pay reasonable compensation for services rendered and made payments and distributions in furtherance of its purpose as set forth herein.

The Corporation shall not participate or intervene, in any manner, in any political campaign on behalf of or in opposition to any candidate for public office. No substantial part of the activities of the Corporation shall constitute the carrying on of propaganda, or otherwise attempting to influence legislation.

Article II

Members and Trustees

A. Members The only members of the Corporation shall be the members of its Board of Trustees.

B. Number of Voting Trustees The number of voting Trustees shall be not less than nine. The President or the President's designee shall be a voting Trustee. No voting Trustees other than the President or the President's designee shall be employed by the School. The remaining eight voting Trustees shall, to the extent practicable, represent the area Catholic parishes, non-Catholic supporters of the School and the various constituencies that comprise the community the School serves.

C. Non-Voting Trustees The voting Trustees may appoint others, including employees of the School, to serve as non-voting Trustees.

D. Quorum The presence of a majority of the voting Trustees (at least five voting Trustees) constitutes a quorum, which is required in order for the Board to act on any matter. Provided that a quorum is present, an affirmative vote of a majority of the voting Trustees is required for action to be taken. However, written action can be taken without a meeting if such action is approved by all of the voting Trustees who would be entitled to notice of such meeting.

E. Election The Trustees shall be elected by majority vote of the Trustees at any meeting called for that purpose.

F. Tenure of Office The President shall serve as a voting Trustee for so long as he or she serves as President or until the President appoints a designee to serve in the President's stead. If the President appoints a designee, the designee shall serve at the pleasure of the President.

The remaining eight voting Trustees shall serve three year terms. Voting Trustees may be re-elected to one additional consecutive three year term.

G. Removal Any Trustee may be removed from office by a unanimous vote of the remaining Trustees for substantial nonperformance of his duties as a Trustee.

H. Vacancies Any vacancy that may occur in the Board of Trustees caused by death, resignation, removal, or otherwise, shall be filled by the President of the Corporation, subject to the approval by a majority of the Trustees. Appointed Trustees shall fill the remainder of the term of the Trustee being replaced and are eligible to serve two consecutive three-year terms thereafter. Resignations must be submitted in writing to the President.

I. Meetings of Trustees Meetings of Trustees shall be held at any time or place pursuant to a resolution of the Trustees or to a call signed by the President of the Corporation or any two Trustees. A ten day notice of such meeting shall be given each Trustee unless the Trustees have fixed a regular time and place for such meetings, in which case no notice shall be required for any meeting. Notice of any meeting may be waived in writing either before or after such meeting. The Trustees shall hold a meeting at least once year.

J. Disclosure of Conflicts of Interest A Trustee shall disclose to the Board any conflicts of interest that arise, and no Trustee shall vote on any matter involving a conflict of interest. In the

event that a Trustee questions whether a conflict exists, the issue shall be decided by a majority vote of the Trustees, provided that the Trustee in question shall not vote.

12. Compensation No member of the Board of Trustees shall receive compensation for his services as such, but the corporation may reimburse reasonable out-of-pocket expenses incurred in the performance of a Trustee's duties.

ARTICLE III

Officers

A. Composition The Officers of the Corporation shall be a President, a Vice-President, a Secretary, a Treasurer and such other officers as the Trustees may establish. The President and Vice –President shall be voting Trustees; other officers may, but are not required to be, voting Trustees. No person shall simultaneously hold the offices of President and Secretary. Officers shall be chosen by the voting Trustees by majority vote and shall hold such offices for a one - year term.

B. Duties.

1. President. The President shall place into operation such policies as shall be decided upon by the Board of Trustees and communicated to the president. The President shall be the principal executive officer of the Corporation and shall, in general, supervise and control all of the activities and affairs of the Corporation. The President shall preside at all meetings of the Board of Trustees. The President may sign, with the Secretary or any other proper officer of the Corporation authorized by the Board of Trustees, any deeds, mortgages, bonds, contracts or other instruments that the Board of Trustees has authorized generally or specifically to be executed, except in cases where the signing and execution thereof shall be expressly delegated by the Board of Trustees, by the Code of Regulations, or by statute, to some other officer or agent of the Corporation; and, in general, the President shall perform all duties incident to the office of President and such other duties as may be prescribed by the Board of Trustees from time to time.

2. Vice President. In the absence of the President or in the event of the President's inability or refusal to act, the Vice President, if any, or if none, the Treasurer, shall perform duties of the President, and when so acting, shall have all the powers of and be subject to all of the restrictions on the President. Any Vice President shall perform such other duties as from time to time may be assigned to him by the President or by the Board of Trustees.

3. Treasurer. If required by the Board of Trustees, the Treasurer shall give a bond for the faithful discharge of his duties in such sum and with such surety or sureties as the Board of Trustees shall determine. The Treasurer shall have charge and custody of and be responsible for all funds and securities of the Corporation; receive and give receipts for monies due and payable to the Corporation from any source whatsoever, and deposit all such monies in the name of the Corporation in such banks, trust companies, or other depositories as shall be selected by the Board of Trustees; and, in general, perform all the duties incident to the office of Treasurer and such other duties as from time to time may be assigned to him by the President or by the Board of Trustees. In addition to fulfilling the foregoing duties, the Treasurer shall render to the President and the Board of Trustees, at the regular meeting of the Board, or when the Board so requires, an account of all of his transactions as Treasurer and of the financial condition of the Corporation.

4. Secretary. The Secretary shall keep the minutes of the meetings of the Board of Trustees in one or more books provided for that purpose; see that all notices are duly given in accordance with the provisions of the Code of Regulations or as required by law; be custodian of the corporate records; and in general perform all duties incident to the office of Secretary and such other duties as from time to time may be assigned to him by the President or by the Board of Trustees.

C. Compensation. No officer shall receive compensation for his services as such, but the Corporation may reimburse reasonable out-of-pocket expenses incurred in the performance of an officer's duties.

ARTICLE IV **Management**

A. Funds. In addition to all of their other powers, the Trustees may maintain two or more separate funds which may be designated by specific names in separate banks and/or investment accounts in furtherance of one or more of the Corporation's purpose.

B. Committees. The Trustees may appoint one or more committees, including without limitation an Executive Committee, of as many Trustees or third parties as are necessary or desirable to administer and manage the Corporation's funds and accounts, and for the other purposes.

C. Rules. Each committee may adopt rules for its own government not inconsistent with this Code of Regulations or with rules adopted by the Board of Trustees.

ARTICLE V **Fiscal Year**

The fiscal year of the Corporation shall begin on the first day of July in each year and end on the last day of June in each year.

Article VI **Indemnification**

Any person who is made or threatened to be made a party to any legal proceeding by reason of the fact that he is or was a Trustee, officer, committee member, agent, or employee of the Corporation, or is or was serving at the request of the Corporation, as a trustee, director, officer, committee member, employee, or agent of another Corporation, partnership, joint venture, trust or other enterprise, shall be indemnified by the Corporation to the maximum extent authorized by the Ohio Non-profit Corporation Law, Section 1702.12 of the Ohio Revised Code.

ARTICLE VII

This Code of Regulations may be amended or repealed by the written assent of all of the Trustees or by a vote of the majority of the Trustees at any meeting called by such a purpose.
